The *Barahatal Rural Municipality , Office of the Rural Municipal Executive* state **has allocated** funds to cover eligible payments under the Contract **for Construction of Taranga Lift Irrigation Project** . Contract No. **BRM/W/NCB/07/075-76**. *Barahatal Rural Municipality , Office of the Rural Municipal Executive, Surkhet* invites sealed bids from all eligible registered Nepalese contractors for submission of their bids electronically. Bidding is open to all eligible as per Section V of bidding document..
2. *Barahatal Rural Municipality , Office of the Rural Municipal Executive, Surkhet* invites sealed bids or electronic bids from eligible bidders for the construction of **Taranga Lift Irrigation Project** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
Only eligible bidders with the following key qualifications should participate in this bidding:
Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 52981214.00**
3. Minimum Work experience of similar size and nature: at least one number of Solar PV Pumping Project Contracts within the last five (5) years, with a value of at least NRs 24724567.00
4. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
5. Eligible Bidders may obtain further information at *Barahatal Rural Municipality , Office of the Rural Municipal Executive, Surkhet* or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
6. Bidders need to submit their bid electronically by downloading the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document worth Rs. 5000 (five thousand only) in the Project's Rajaswa (revenue) account as specified below .

8. Bidders shall have the option of submitting their bids : "**by electronic only**". Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 hrs 2076/01/10** at the office of *Barahatal Rural Municipality , Office of the Rural Municipal Executive, Surkhet*. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs.1,121,000.00**, which shall be valid for 30 days beyond the validity period of the bid.
10. The unit price furnished in words shall prevail in case of any discrepancy between figures and words.
11. Matters not covered by this notice shall be in accordance with Public Procurement Act 2063 (First amendment 2073 as well and Public Procurement Regulation 2064.
