- 4. Electronic bids must be submitted to the office *Barahatal Rural Municipality*, *Office of The Rural Municipal Executive*, *Kunathari*, *Surkhet* through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 noon on *April 02,2024*. Bids received after this deadline will be rejected.
- 5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00 PM April 02,2024 at the office of Barahatal Rural Municipality, Office of The Rural Municipal Executive, Kunathari, Surkhet. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 45,000/-, which shall be valid for 30 days beyond the validity period of the bid.
- 6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the **bid and** bid security shall remain the same as specified for the original last date of bid submission.
- 7. All other terms and conditions will be as per Nepal Government's prevailing Procurement Act and Regulations. *Barahatal Rural Municipality, Office of The Rural Municipal Executive, Surkhet* reserves the right to accept or reject the Bids.
