The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00 PM 2080/09/02 at the office of Barahatal Rural Municipality, Office of The Rural Municipal Executive, Kunathari, Surkhet. Bids must be valid for a period of 45 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 30,000/-, which shall be valid for 30 days beyond the validity period of the bid.
- 6. If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the **bid and** bid security shall remain the same as specified for the original last date of bid submission.
